The amount of building fund per student is determined by that student's grade level.

Maximum of \$1,200 per family/household regardless of the number of children that family enrolls at Calhoun Academy

All new students entering Grades 1 - 12, including those who attended Kindergarten at Calhoun Academy, will pay a \$100 Application Fee. That \$100 is the first payment toward the Building Fund for a student.

In addition, students entering grades $1^{st} - 10^{th}$ will pay an additional \$25 per quarter or \$100 per year until paid in full.

<u>Students entering 11th grade</u> will pay an additional \$37.50 per quarter or \$150 per school year for the next two years. In total, \$400 will be paid for that student by the end of their senior year at Calhoun Academy.

<u>Students entering 12th grade</u> will pay an additional \$75.00 per quarter or \$300 during their senior year. In total, \$400 will be paid for that student by the end of their senior year.
